Council of the University

Council has made the following changes to regulations, to come into effect on **30 January**, unless notice of a resolution calling upon Council to annul or amend

Regulations for University Officers

Explanatory Note

The roles of Pro-Vice-Chancellors with portfolio are largely fractional to allow for coverage of a broader set of key portfolios, and to enable postholders to continue in their academic roles part time. Due to the need to create more flexibility with the amount of time dedicated to the Pro-Vice-Chancellor portfolios, Council has agreed that the total full-time equivalent allowance for these appointments be increased from 5 to 6. Numbers are also being written as numerals rather than words, in line with Oxford style guidance.

Text of Regulations

In [Council Regulations 21 of 2002](#), concerning University Officers, amend as follows (new text underlined, deleted text struck through):

the regulation is received by the Registrar by **noon on 26 January** (as set out in section 19(1)(a) of [Statute VI: Council](#)).

‘10. (1) There shall be no more than the equivalent of ~~five~~6 full-time Pro-Vice-Chancellors who shall be appointed by the Vice-Chancellor subject to the approval of Council and each of whom shall have special responsibility for designated functions as agreed by Council on the recommendation of the Vice-Chancellor.

(2) The period of the appointment of these Pro-Vice-Chancellors, shall be determined by Council on the recommendation of the Vice-Chancellor.

11. The Vice-Chancellor may appoint any members of Congregation as additional Pro-Vice-Chancellors, on condition that the total number of such additional Pro-Vice-Chancellors serving at any one time shall not exceed ~~ten~~10.’

General Purposes Committee of Council

The General Purposes Committee of Council has made the following changes to regulations, to come into effect on **30 January**, unless notice of a resolution calling upon

(a) Moores Professor of Management Studies

Explanatory Note

These proposed changes are to add research to the duties of the professor, to update the requirement to consult with the Peter Moores Foundation, as this foundation no longer exists, and to reflect the current department and divisional structure.

Text of Regulations

In [Council Regulations 24 of 2002](#), concerning the Moores Professorship of Management Studies, amend as follows (new text underlined, deleted text struck through):

‘1. The Peter Moores Professor of Management Studies shall undertake research, lecture and give instruction in Management Studies.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the Warden of Wadham College is Vice-Chancellor, a person appointed by Council;

Council to annul or amend the regulation is received by the Registrar by **noon on 26 January** (as set out in [Statute VI: Council](#)).

(2) the Warden of Wadham College, or, if the Warden is unable or unwilling to act, a person appointed by the governing body of the college;

~~(3) the Peter Moores Director of the Saïd Business School;~~

~~(4) a person appointed by the Governing Body of Wadham College;~~

~~(3), (4)(5), (6) two persons appointed by Council, one of whom shall be appointed after consultation with the Peter Moores Foundation or its nominated representative;~~

~~(7) a person appointed by the General Board;~~

~~(8) a person appointed by the Board of the Faculty of Management;~~

~~(9), (10) two persons appointed by the Board of the Faculty of Social Studies.~~

(5) the Head of the Social Sciences Division, or their nominee;

(6)–(8) three persons appointed by the Saïd Business School

(b) Professor of Medical Statistics

Explanatory Note

These regulations are being amended to reflect the decision to rename the Professorship of Medical Statistics to the Professor of Regulatory Health Data Science, in alignment with the department's strategic priorities.

Text of Regulations

In [Council Regulations 24 of 2002](#), concerning individual professorships, change the name of the Professorship of Medical Statistics as follows (new text underlined, deleted text struck through):

~~'Professor of Medical Statistics~~Professor of Regulatory Health Data Science

1. The Professor of ~~Medical Statistics~~Regulatory Health Data Science shall undertake research, lecture and give instruction in ~~Medical Statistics~~Regulatory Health Data Science.

2. The professor shall be elected by an electoral board consisting of:

~~The above provision regarding consultation with the Peter Moores Foundation shall not be amended or repealed without the prior agreement of the foundation.~~

3. The professor shall be subject to the General Provisions of the ~~regulations~~decree concerning the duties of professors and to those Particular Provisions of the same ~~regulations~~decree which are applicable to this chair.'

(1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the professorship shall be for the time being allocated by Council under any decree in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college;

(3) a person appointed by the governing body of the college specified in (2) of this clause;

(4)–(5) two persons appointed by Council;

(6) the Head of the Medical Sciences Division or his or her nominee;

(7)–(9) three persons appointed by the Medical Sciences Board.

3. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.'

Degree by Diploma

The degree of Doctor of Civil Law, [approved by Resolution of Congregation on 18 November 2025](#), was conferred upon **His Excellency Frank-Walter Steinmeier**, President of the Federal Republic of Germany, at a private ceremony on 5 December in Convocation House.

The Public Orator made the following speech in presenting to the recipient of the degree of Doctor of Civil Law:

AND WHEREAS German Studies have long flourished among us, with generous support from citizens of his Germany;

AND WHEREAS his contribution to our mutual relations has been recognised in his becoming a Knight Grand Cross of the Order of the Bath;

AND WHEREAS he has used his study of law and political science in pursuing a distinguished career in public service;

AND WHEREAS in that career he has consistently supported the ideals of democratic government, balancing the vital interests of human rights and political stability;

AND WHEREAS he has shown an understanding of the limits as well as the advantages of international agreements;

AND WHEREAS he recognises the needs and rights of nations to protect their very existence;

NOW THEREFORE WE, in recognition of his eminent sagacity, wisdom and culture, do here in this our Convocation House proclaim the aforesaid President a Doctor in our Faculty of Civil Law, and by the power and force of this Diploma do hereby invest him with all the rights and privileges which belong to this degree.

IN WITNESS WHEREOF we have caused to be affixed to this instrument the Seal of the University thereunto pertaining.

members of Congregation that they wish the resolution to be put to a meeting of Congregation.

Voting on a Resolution authorising the allocation of space called the Garden Land to Kellogg College

Explanatory Note

As required by section 4 of Statute XVI, approval of this resolution is requested because of the size of the proposed space allocation.

The Garden Land comprises land which has previously been allocated in its entirety between Reuben and Kellogg Colleges on 21-year terms for use as amenity land in conjunction with the use of the villas as graduate accommodation. 2–6 Winchester Road was allocated to Reuben College from 1 August 2024; 49 and 55 Banbury Road were allocated to Kellogg College, also from 1 August 2024; 47 Banbury Road was allocated to Kellogg from 17 October 2025 following the decant of the Faculty of History to the Schwarzman Centre; 51–53 Banbury Road has been allocated in principle to Kellogg but remains occupied by the School of Anthropology and Ethnography (SAME) until the development of 25 Wellington Square has completed (estimated 2029 at the earliest). In each case, the allocations were subject

to take-back provisions in relation to the rear gardens, and with the express proviso that no development could be undertaken in the gardens, with the intention being that a further allocation would be brought forward if the development of the new builds by either college were to proceed. Reuben College has withdrawn from the project and notice has been served to call back the rear gardens of 2–6 Winchester Road to facilitate their re-allocation to Kellogg College as part of the Garden Land allocation. In addition, the rear gardens of 51–53 Banbury Road will be withdrawn from functional use, albeit the building will remain occupied by SAME. The new Garden Land allocation will expressly permit the construction of 3 new-build graduate accommodation blocks, supporting Kellogg's commitments to increase graduate numbers.

Text of Resolution

That the site comprising approximately 1,773 sqm of land currently forming the rear gardens of 2–6 Winchester Road and 47–55 Banbury Road (the Garden Land), be allocated to Kellogg College for a term of 21 years from a commencement date provided for in the Heads of Terms (after Kellogg has evidenced funding for the project, obtained the necessary University governances for the allocation and Heads of Terms, and entered into a building contract), for the construction of 3 new-build graduate accommodation blocks, together with associated landscaping works.

In addition, that further land comprising approximately 602 sqm at the rear of 2–6 Winchester Road and front and rear of 45 Banbury Road be allocated to Kellogg College on a temporary basis for the period of the construction works, for use by the contractor and to undertake landscaping works as part of the project.

Nominations

Hard copies of nomination forms will not be processed. Nominations must be made on an official [nomination form](#). Completed nomination forms must be sent as an email attachment to the [Elections Office](#) by 4pm on Thursday, 5 February. Please ensure that the nominators listed in section D are also copied into the email when the nomination form is submitted, as this will act as verification of the nomination in lieu of supplying original signatures.

General requirements and eligibility

All candidates are asked to note the general requirements which apply to all committee members, as set out in [Council Regulations 14 of 2002 \(General Regulations of Council for Committees\)](#). Current members seeking re-election are also asked to check for specific restrictions on consecutive service. For further information, please see the [eligibility](#) and [amendments to nominations](#) sections within the [Information about University elections pages](#) of the [Elections](#) website.

Candidates' statements

Candidates are invited to include with their nomination forms a written statement of no more than 250 words, setting out their reasons for standing and qualifications for the office being sought.

Contested elections

In the event of a contested election, the successful candidates will be determined by an electronic ballot. An email with further instructions will be sent to eligible voters on Wednesday, 18 February, using the email addresses provided in the electronic register of

Congregation (NB with few exceptions, notably clinical staff, this will be the work address ending 'ox.ac.uk'). Candidates' statements will be published online and in the *Gazette* dated Thursday, 19 February. Voters may wish to read these statements before completing their electronic vote. The voting period will close at 4pm on Thursday, 5 February 2026.

Uncontested elections

If the number of nominations received by the closing date is no more than sufficient to fill the vacancies, the candidates nominated shall be deemed to be duly elected as of the close of the nomination period on Thursday, 5 February. When required, places will be allocated according to academic standing, as defined in [Council Regulations 22 of 2002, Part 2: Academic Precedence and Standing](#). If the number of nominations received by the closing date is less than sufficient to fill the vacancies, those candidates nominated will be deemed elected unopposed, and the remaining vacancies will lapse, in which case, in accordance with the regulations, the places must remain vacant until appointments are made jointly by the Vice-Chancellor and Proctors.

Period of office

In accordance with [Congregation Regulations 2 of 2002](#), in any election where vacancies are to be filled for periods of different length, the elected candidates shall hold office so that the tenure of those who receive more votes shall be longer than that of those who receive fewer votes; but if the election is uncontested or if two candidates receive the same number of votes, the candidate senior in academic standing shall hold office for the longer period.
